

## **Terms & Conditions of Purchase**

This Agreement sets forth the terms of purchase for your purchase of Accept and Rock Your Perfectly Imperfect Body by Dr.Sharon Galor. This Agreement will be effective consistent with the terms indicated on the sales page.

By placing your Order with Dr.Sharon Galor, by clicking “confirm,” you agree to be bound by this Agreement. If you do not agree with these terms, you should leave the website or the applicable purchase page and discontinue use of the services immediately.

In these terms and conditions, “the practice” means The Light Wave Psychologists Practice, The program means “Accept and Rock Your Perfectly Imperfect Body“. “You/your” means you as a user of the Website and/or Customer of the Program/Services.

### **The Services**

“Accept and Rock Your Perfectly Imperfect Body” is an online CBT program that will provide you with psycho-educational information, strategies, challenges, experiments, forms, which will create emotional, cognitive and behavioral changes in your life. It will help you adjust and improve your body image to a degree that will make you comfortable within your own skin, more accepting of your shape and embracing your inner and out beauty alike. It contains 12 modules that can be done online. Your progress will determine the tempo and length that it takes you to go through the 12 modules.

Additionally you get maximum of 8 emails to support you when you need it. You can choose to join a private group to ask questions, get peer support , raise your motivation or accountability, exchange ideas and thoughts or express your emotions. You are not obligated to join. It is a bonus value to the program. A month after completion you will be contacted in a form of 15 minutes call to discuss your progress and answer your new questions. You can also upgrade to the Platinum program and get these additional features: 6x 90 minutes private sessions; occasional check in's to boost your motivation and support and the bonus values is the group sessions. The 2 group sessions are 1 hour long with a grace period of 15 minutes. It is your personal choice to sit in a group session and share your experience, get feedback with others. It is a more personal level of interaction that many find helpful. The peer sessions will be guided by Dr.Sharon Galor. Should there will not be enough participants who want to join a group or that you are really uninterested in group sessions then you will get 1 hour private session.

You will use a personal username and password that should only be used by you to access the Content. Sharing log-in information, passwords, any content and protected links with non-members is prohibited and will result in removal from the program (without refund).

### **Payment**

Payment is required before beginning the program, as indicated on the sales page and it is a one-time fee. Please check the specific details of your desired program on the website.
